IMPORTANT

Morden Park swimming pool – Secondary Pool has a height adjustable floor. If this pool is being used it is essential that the depth is checked by more than one person. The depth maybe changed during the session, but no swimmers should be in the pool whilst the floor height is altered.

Leisure centre management asked to check changing rooms and poolside for problems and obstacles before club attends the centre for any sessions.
